NOTICE IS HEREBY GIVEN that Lehi City will hold a public comment period and a public hearing to receive input on a proposed Substantial Amendment to its PY19 Annual Action Plan. This amendment pertains to the use of Community Development Block Grant - Coronavirus (CDBG-CV) funds, originally allocated under the CARES Act, to prevent, prepare for, and respond to the coronavirus pandemic.

The proposed Substantial Amendment No. 2 aims to reallocate unexpended CDBG-CV funds from CV-Parks and Recreation Facilities to two public service activities due to the project coming in under budget.
